Limited Registration Guidelines

1 You must be a financial member of the Chrysler Owners Club of Queensland Inc.

NOTE: New members should complete and/or confirm membership prior to application for Special Interest Vehicle Registration.

2 Your vehicle must be at least 30 years old. (to the month)

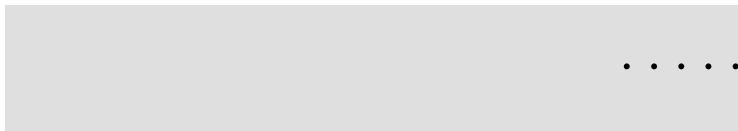
3 A current photograph of the vehicle must be supplied.
(Digital images provided in JPG format are acceptable)

4 A SIV Certification form needs to be obtained. (See section 5.)

Your current financial status will be checked and certified on this form.

(A SIV Certification administration fee of \$50.00** is payable to the Chrysler Owners Club of Queensland Inc for this service, prior to the provision of this form.)

5 Your vehicle must be inspected by a Chrysler Owners Club of Queensland Inc. dating officer. (You will receive the Chrysler Owners Club of Queensland Inc SIV certification form certified by the Club officer. This form will be provided by the officer for verification and certification of the vehicle details and your current membership status.)
